- 1. An application must be completed for each applicant regardless of age for enrollment. Leave no questions unanswered.
- 2. Complete the attached genealogical chart.
- 3. Provide original copies of birth, marriage, divorce, and death records. No hospital or funeral home records are accepted. Certified copies of wills, deeds. Must have the name of the book, page number, location, and office. Original copies are the ones that have the watermark.
- 4. Copies of books, bibles, must be certified by a notary that they are an exact copy of the original document. Must have a copy of the title page that shows the name of the book and copyright date, name, and location of publisher. Include location and address of the site. May request to see these items of documentation.
- 5. Provide certified copies of any other documents that will allow us to verify your Creek Indian heritage. Must have the name of the book, page number, location, and office.
- 6. There must not be a genealogical break in belonging to the Ma-Chis Lower Creek Indian Tribe of Alabama.
- 7. The applicant must provide a passport picture to place in the notebook. For applicants 18 years old and above, please enclose a PASSPORT photo of yourself as well as a legible copy of your State Driver's License or State ID. (Photo Criteria: color, 2" x 2", white background) (NO Polaroid or Professional Photos) Applicants 17 years and younger Include a passport picture and a copy of parents state issued ID. If unsure about Passport photos, please review this website: http://travel.state.gov/content/passports/english/passports/photos.html
- 8. The application must be completed on both maternal and paternal sides of the family.
- 9. Provide certified copies of any documents that may have legally changed the applicant's name.
- 10. Provide copies of census records as made available by the United States Census Department must provide proof where this information is obtained.
- 11. No statements are accepted for proof as "I know \_\_is a Creek Indian."

- 12. All applications/documents will become the property of the Ma-Chis Lower Creek Indian Tribe of Alabama. They will not be returned to the applicant.
- 13. **ADOPTIONS**: Must submit the certified copy of Petition and Final Decree of Adoption and must include a State Certified Full Image Birth Certificate (After Adoption).
- 14. VETERANS: Applicants, who are veterans, please submit your DD Form 214.
- 15. Must provide a legible copy of your state-issued driver's license or state ID.
- 16. The application of an applicant less than eighteen (18) years of age shall be submitted only by the applicant's parent possessing legal custody of the minor or by his/her legal guardian and must be signed by the person applying. Proof of guardianship and or custody must accompany the application.
- 17. The person who signs the application is required to enclose a copy of his/her state ID or state driver's license.
- 18. The application of an applicant, eighteen (18) years of age or older, must be signed the applicant or by the applicant's legal guardian Proof of guardianship must accompany the application.
- 19. If you are reapplying for citizenship, complete the following additional instructions. You must write a letter explaining why you have not maintained contact in writing with the Ma-Chis Lower Creek Indian Tribe of Alabama Tribal Office. Also, why you have not attended meetings, tribal events, and cultural gatherings. Why you think that you will now maintain affiliation. The explanation must cover each year that Tribal affiliation has not been maintained.
- 20. If you are applying for citizenship, complete the following application. You must write a letter explaining why you are seeking citizenship into the Ma-Chis Lower Creek Indian Tribe of Alabama.
- 21. If not typed this application must be written in blue or black ink and must be legible.
- 22. No one may apply for citizenship into the Ma-Chis Lower Creek Indian Tribe of Alabama other than oneself or minor child/children (18 years and younger).

# We may request additional information; we feel necessary to complete the process. <u>No person</u> shall be eligible for enrollment if he or she is an enrolled member of another tribe, band, clan, nation, or group that is recognized either by state, federal, or unrecognized.

The information must be placed in a three-ring binder. The application first, followed by the genealogical chart. Then each person must have an individual section completed on their demographics consist of birth, marriage, divorce, death, census, deeds, wills, and any additional information proving citizenship. The application and documents become the property of the MaChis Lower Creek Indian Tribe of Alabama.

There may be a \$500.00 verification fee charged and is non-refundable per applicant. The applicant will be researched to determine the applicant citizenship status. THE TIME FRAME FOR THE ENROLLMENT PROCESS OF YOUR CITIZENSHIP APPLICATION VARIES DUE TO THE APPLICATIONS BEING PROCESSED ON A CASE BY CASE BASIS. -IN THE REVIEW PROCESS OF THE APPLICANT'S DOCUMENTATION AND DIRECT LINEAGE,

PLEASE BE AWARE THAT ADDITIONAL DOCUMENTATION MAY OR MAY NOT BE REQUESTED AFTER THE INFORMATION IS REVIEWED.! REMEMBER: All incomplete applications will be returned. If other documents are needed, you will be contacted.

The Ma-Chis Lower Creek Indian Tribe of Alabama Tribal Council will determine citizenship status, which is the final authority.

If approved for citizenship no roll number, identification letter, or benefits will be issued until at the end of up to seven years' probation. During the seven-year probation, you must attend three-fourths of the yearly meetings and cultural events such as pow wow, green corn, and so forth.

**No faxes, emails accepted**. The application must be mailed to tribal office, as stated in the tribal letterhead.
